### The MoreClub Mondays and Wednesdays Swipe and Win in July

#### OFFICIAL RULES – KIOSK PROMO

**NO PURCHASE IS REQUIRED IN ORDER TO PARTICIPATE AND RECEIVE AN OPPORTUNITY TO PLAY THE MORECLUB SWIPE AND WIN GIVEAWAY AS DETAILED BELOW. YOU MUST BE PRESENT TO PARTICIPATE AND SWIPE YOUR MORECLUB CARD AT THE MORECLUB KIOSK.** Jerry's Nugget Casino MoreClub Swipe and Win Giveaway (the "Promotion") will begin on Monday, July 5, 2010 and is scheduled to end on Wednesday, July 28, 2010 (the "Promotion Period"). The Promotion is available on Mondays and Wednesdays only throughout the promotional period. The Promotion is sponsored by Jerry's Nugget Casino.

1. **ELIGIBILITY.** Players must have a valid MoreClub card in order to participate. MoreClub cards may be obtained at the MoreClub Center. Membership is free. A valid I.D. is required in order to obtain a MoreClub card, establish membership, redeem points or purchase with comp. Please visit the MoreClub Center for complete rules on the benefits of membership. All participants must be 21 years of age or older. Persons who are trespassed and/or self-excluded from Jerry's Nugget Casino are not eligible to participate in this Promotion. Employees of Jerry's Nugget Casino, its subsidiaries, related companies, and lessees are not eligible to participate in the Promotion.
2. **HOW TO PARTICIPATE – Slots, Video Poker, Video Keno players.** In order to be eligible to play The MoreClub Swipe and Win Giveaway game at The MoreClub Kiosk participants must earn the required 25 MoreClub base points on Mondays and/or Wednesdays by playing slots, video poker or video keno in one day's play. Bonus and promotional MoreClub points do not count as "earned" base points and are therefore excluded toward the 25 point minimum required. The day played is denoted from 4:00 a.m. until 11:55 p.m. It is the participant's responsibility to successfully swipe their MoreClub card at the kiosk during the Promotion Period. Participants must swipe at the kiosk no later than 11:59 p.m. the same day they earn the 25 required base points in order to receive a Swipe and Win Giveaway prize.
3. **PRIZES AWARDED.** Participants will receive a kiosk ticket denoting their prize along with details on how to redeem. No ticket will print for the point and comp rewards. Point and comp multipliers will be adjusted to the customer's account the following day. Free points and comp amounts will be automatically adjusted to a player's account on that same day. A kiosk ticket will print for all other prizes.
4. **PRIZES.** An electronic gaming customer (slots, video poker and video keno) can receive one Swipe and Win Giveaway reward each day they successfully earn the required 25 MoreClub points during the specified time period. The kiosk ticket must be surrendered upon redemption. No points are subtracted from a player's account for their Swipe and Win Giveaway reward.
5. **CLAIMING A PRIZE.** The redemption location and method for claiming prizes via a printed ticket will be denoted on the ticket. All Cash rewards will be awarded at the Main Cage. For all other prizes the redemption process will be noted on the ticket. All applicable taxes are the sole responsibility of the winner. Winners will be required to provide their MoreClub card and valid photo identification when claiming their prize.

6. **OTHER CONDITIONS.** Club membership and benefits are non-transferable. Points and Comp are non-transferable. Points and Comp will expire after 14 months of uncarded play. Terms subject to change. Jerry's Nugget Casino reserves the right to void or disqualify any participant, and/or to change, cancel, or modify this Promotion at any time. Participating in this Promotion constitutes an agreement to be bound by these Official Rules and decisions of Management.
