YOU MUST BE PRESENT TO PARTICIPATE AND CONDITIONS AS STATED IN RULE #4 MUST BE MET. Jerry's Nugget Casino Bingo Nugget Ball (the "Promotion") will be held every day at every bingo session for the amount posted for each session (the "Promotion Period"). The Promotion is sponsored by Jerry's Nugget Casino.

- 1. The Nugget Ball will be drawn during the Letter J game and announced to the room, and then available at the start of Game #2.
- The Nugget Ball will be in effect games #2 through #13 on all regular sessions. The Nugget Ball is not valid on Dual Dab, Letter J, Second Chance Coverall, and Second Chance Bingo Games (4, 7, 11, 14 and 17). The Nugget Ball is not valid on unvalidated Super Coveralls.
